The Technical Consultancy Development Programme for Asia and the Pacific (TCDPAP)

Technical Consultancy Development Programme for Asia and the Pacific (TCDPAP) is a programme promoted by UN-ESCAP for developing consulting capabilities at National, Sub-Regional and Regional levels in the Asia and Pacific Region. The programme comprises 14 countries of Asia and the Pacific region as members namely, Bangladesh, China, India, Indonesia, Iran, Korea, Malaysia, Myanmar, Nepal, Pakistan, Philippines, Sri Lanka, Thailand and Vietnam.

Over the years TCDPAP has played an important role in developing cooperation amongst the countries in capacity building, developing consultancy opportunities and sharing of resources. TCDPAP also promotes collaboration and global partnerships.



Construction Industry Development Board Malaysia [CIDB]

CIDB Malaysia was established in 1996, a statutory body under the Ministry of Works Malaysia to coordinate activities of the construction industry. Association of Consulting Engineers Malaysia (ACEM)

ACEM was established in 1963 with the primary objectives of:

Any new title of the paper consistent with the conference theme and objectives may be considered by the conference secretariat upon receipt of an abstract. Those desirous of presenting a paper in the conference are requested to send the abstract not more than 500 words by **17 March 2011**, and upon acceptance, the full paper in English before or by **1 April 2011**, on the related topic to the theme and objective of the conference.

Presentation of the selected papers in the technical sessions of the conference through use of multimedia (.ppt) shall be limited strictly to 15 minutes.

Authors are requested to observe the following guidelines for papers as follows:

The paper should not be less than 15 pages but not exceeding 20 A4-size pages under the following specifications and should be in black and white only. It may contain elements in color.

The title (Times New Roman, bold 14, centered) should have a maximum of 60 characters in English, without abbreviations. Body text should be written in Times New Roman, 12 pt, line spacing 12 pt. There should be no hyphenation (cutting words) and the text should be left justified only. Main headings in the text should be written in bold 14 pt; subheadings in 12 pt; and 3rd level headings in 12 pt. Headings should be limited to three levels and numbered appropriately. Please provide a single line (12 pt.) space between the previous section and all headings and two blank lines between headings and the following text, graphic or table. Heading numbers should be left justified with the text indented 10 mm. Footnotes should no be used.

Drawings, photographs and tables should be inserted electronically into the paper. Scanned drawings and tables inserted as bitmaps are not acceptable. The resolution profile should be 150×150 dpi (dots per inch) for photographs and 300×300 psi for drawings. Original photographs (32×48 mm) should be attached.
