FIDIC / ASPAC &TCDPAP International Conference at Seoul, Korea 2008

The FIDIC/ASPAC & TCDPAP International conference on "Role of Engineering in the Globalization Era" was held at Seoul Korea in 22-25 April 2008, hosted by Korea Engineering and Consulting Association (KENCA) in association with the International Federation of Consulting Engineers (FIDIC) and FIDIC Member Associations of Asia-Pacific Region (ASPAC) was joined by Secretariat for Technical Consultancy Development Programme for Asia and the Pacific (TCDPAP). ASPAC had given full support and contribution to the conference.

At the Conference, we discussed the role of engineers and engineering in respect of design,

construction and environmental issues and could share our experience and the knowledge.

Technical sessions were the following three themes.

- Solving the Disparity in Engineering Techniques
- Outsourcing: Human Resources

ASPAC Extra Meeting at Seoul



Point of the meeting

- Mr. Hirotani welcomed all delegates to the meeting and presented the Agenda for the meeting;
 - -Progress of the ASPAC Action Plan
 - -Proposed to set up ASPAC YPF (Young Professionals Forum)
- ASPAC Action plan: ASPAC secretariat, Mr.Akasaka, explained about ASPAC action plan and how it is progressing. The ASPAC activity 2007 was also introduced, such as participation in the conference held at Lahore and Singapore, and issue of ASPAC regional news, and having some seminars. Based on the plan, ASPAC try to share the information among member associations, so secretariat asked the member associations to cooperate to collect information of each member.
- **DAB seminar in Asia:** Secretariat also introduced future event such as seminar for dispute adjudication Board in Asia. Dr. Yamasita, secretary general of AJCE, explained this seminar in detail. Named to 'the study on promotion plan of adjudicators in Asian region' was promoted by JBIC (Japan Bank for International Corporation) and AJCE. Seminars are conducted first in

Tokyo and Kyoto in July, and then in Manila in mid to late August. The result of this study would be reported in Quebec conference.

- ASPAC YPF: ASPAC secretariat, Miss Watatsu, explained about ASPAC YPF (Young Professionals Forum). ASPAC YPF is the place for young consulting engineers to communicate and enlighten each other. This rough proposal would be suggested to the ASPAC GAM formally in next Quebec conference. Secretariat asked the member associations to recommend young engineer as a Steering Committee members.
- Chairman informed that he received 6 country reports from India (CEAI), Sri Lanka (ACESL), New Zealand (ACENZ), Australia (ACEA), Vietnam (VECAS) and Pakistan (ACEP).
- Message from FIDIC President: Mr.John Boid, FIDIC President, focused that FIDIC have recognized that delivery of the best practices is just as important as putting them together and documenting them. He mentioned that he would support ASPAC because the activity of regional grouping within FIDIC is developing, and becoming increasingly significant. He also proposed that ASPAC has some informal sub-grouping according to different needs, because there are many countries in ASPAC region that are in very different stages of development.
- Message from FIDIC Managing Director: Mr.Enrico Vink, FIDIC Managing Director, focused that FIDIC have been expanded the activities in recent times within Asia. FIDIC could expand the range of training programs to support MA.Regarding the ASPAC YPF, this is a logical link between the FIDIC young professional programs. He also pointed out that there was certainly a strong need and demand for adjudication at a more local level and FIDIC will work with member collectively or individual countries.
- The end of the meeting, Chairman thanked members for their strong support. There was a very
 - rigorous opinion exchange and information.

 Chairman mentioned that we should show the presence of ASPAC and consulting engineers in this region, because ASPAC region was facing very rapid economic development and consulting engineers were riding the wave, building capacity as consulting engineers very, very rapidly.
